General Notes:

Business day shall be considered to be every day from Monday to Friday, with the exception of national holidays in the Republic of Serbia, when the Bank receives payment orders for realization in accordance with the business hours of the Bank's sub-branches and pursuant to the time enabled for the receipt of E-banking order (for internal transactions Saturday shall also be considered the business day).

The business day is the day, and/or the part of the day where the Bank operates in such a manner as to enable the

execution of payment transactions, in compliance with the Time Schedule.

The orders received after the time indicated in the Time Schedule, shall be deemed to be received on the next business day of the Bank.

Order receipt time is the time when, pursuant to the Time Schedule, the Bank shall be deemed to have received the payment order. Receipt time of payment order issued by the e-bank service is the time when the same was entered in the information system of the Bank's payment system.

The Bank reserves the right, on the day of receipt of payment order and within the scope of its ability, to execute, as well, the payment orders received after the deadlines defined in this Time Schedule.

If the date of execution is not indicated on the payment order it will be deemed that the desired date for execution of order is equal to the date of receipt of the order.

With regard to transfer order with the execution date in the future, the Bank shall execute those on the execution date as stated on the payment order.

If at the time of delivery of payment order, there are no sufficient funds on the account for execution to be carried out, and the user provides the funds within the next two days, the day when the user provided the funds shall be considered the payment order execution day. If, after two days, the user fails to provide the funds for order execution, it shall be deemed that the user cancelled the payment order and the Bank shall not be obliged to notify the user thereof. Failure to execute the payment order due to blockage of the payer's account shall not be considered as rejection of the payment order and the Bank shall not be obliged to notify the user thereof.

General Notes:

Business day for execution of international payment transactions shall be every day from Monday to Friday, with the exception of national holidays in the Republic of Serbia

The business day is the day, and/or the part of the day where the Bank operates in such a manner as to enable the execution of payment transactions, in compliance with the Time Schedule.

The orders received after the time indicated in the Time Schedule, shall be deemed to be received on the next business day of the Bank.

Order receipt time is the time when, pursuant to the Time Schedule, the Bank shall be deemed to have received the payment order. Receipt time of Payment order issued by the e-bank service is the time when the same was entered in the information system of the Bank's payment system.

The Bank reserves the right, on the day of receipt of payment order and within the scope of its ability, to execute, as well, the payment orders received after the deadlines defined in this Time Schedule. For international payment transactions the Bank guarantees the execution deadline stipulated by this Time

For international payment transactions the Bank guarantees the execution deadline stipulated by this Time Schedule up to the first bank participating in the mediation, and/or execution of the payment order.

Payment orders in favor of payee's account within the European Union amounting up to EUR 50.000,00, which the Bank receives by the time prescribed for the receipt of order, will be processed the same day by delivering the order to the correspondent bank abroad. The correspondent bank will try to transfer the funds to the beneficiary bank with a value date not longer than two business days from the day of receipt of the payment order. Beneficiary bank will credit the payee's account in accordance with its business policy.

The Time Schedule for receipt and execution of payment transactions is valid and applies to the orders that are accompanied with the required documentation and for the execution of which the coverage has been provided.

Deviations:

Pursuant to restrictions in the work of the Bank's payment system or the payment system of the National Bank of Serbia, and/or the payment system of another payment institution.
